

AGREEMENT ON THE PROTECTION OF RIGHTS AND INFORMATION, ADVERTISING BROADCASTING.

Rules and conditions for the use of personal data

1. YOUR CONSENT

By entering your personal data on the sites <https://www.crefrussian.ru/> and <https://cref.langlion.com/> (private establishment of professional and complementary education "CREF-R"), you accept by default that this data may be used by CREF-R or CREF-R affiliates for the dissemination of information and advertising, including by email and SMS; your data is protected under the Agreement on the Protection of Rights. You may refuse the receive of any advertising information sent by CREF-R and CREF-R affiliates after we have requested it (our contacts: telephone +7-495-545-47-45, e-mail address: russian@cref.ru)

2. YOUR CONTACT DATA

When booking a service or attempting to take the free test on our site, it is essential for us to collect your personal data such as your name, email address and phone number. We do not disclose your personal data outside of our organization.

CREF-R can access information about the number of visits to the site <https://www.crefrussian.ru/> (for example, the number of daily visits to our site). This data is only used in aggregate (as summary information) and does not contain any personally identifying information.

4. USE OF COOKIES

CREF-R uses "Cookies" to gather information. "Cookies" are information files that are transmitted from the website and are saved on your computer's hard drive to preserve the data. These files allow us to track the traffic to our website: how and in what numbers users access our site.

"Cookies" can not identify the user's computer and do not keep personal identification information. We do not analyze the information received by "Cookies" and do not compare it with other personal data in order to know your name (or that of the user of your computer) or your email address.

Most web browsers provide "Cookies" access by default. However, you can use another web browser to deny access. If you do so, it will no longer be possible for you to enjoy all the benefits offered by our site. For example, to be able to pass our free test in its entirety on the site, it is essential to authorize "Cookies".

5. DATA ACCURACY

Upon your request, CREF may (but does not assume any obligation to) supplement, correct or remove any incomplete, inaccurate or outdated information about your data.

6. DATA SECURITY

The personal data collected by the CREF is stored in protected and closed databases.

7. OTHER TERMS NOT COVERED IN THIS AGREEMENT ON THE PROTECTION OF RIGHTS

The personal data which you leave during communication in chat or by exchange of emails is not subject to the Agreement here-to-present. We do everything necessary to protect your personal information and ensure control of all sessions. Remember, however, that during your conversations on the forum it is up to you to control what personal information you reveal. Be careful when releasing your personal data in this way!
